On July 30, 2010, in Case No. 2009-00549,¹ the Commission approved rates for Louisville Gas and Electric Company ("LG&E") and provided for their further adjustment in accordance with LG&E's Gas Supply Clause ("GSC").

On June 30, 2011, LG&E filed its proposed GSC to be effective August 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. LG&E's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. LG&E's Expected Gas Cost ("EGC") is \$.57032 per 100 cubic feet, or \$5.7032 per Mcf, which is a decrease of \$.0407 per Mcf from the previous EGC of \$5.7439 per Mcf.

3. LG&E's notice sets out a current Refund Adjustment ("RA") of (\$.0043) per Mcf. LG&E's total RA is (\$.0128) per Mcf, which is \$.0022 per Mcf less than its previous total RA of (\$.0106) per Mcf.

4. LG&E's notice sets out a current Actual Adjustment ("AA") of \$.0543 per Mcf. The total AA of (\$.1058) per Mcf is an increase of \$.1272 per Mcf from the previous total AA of (\$.2330) per Mcf.

5. LG&E's notice sets out a (\$.0386) per Mcf current Balance Adjustment ("BA"), which is a decrease of \$.0936 per Mcf from the previous BA of \$.0550 per Mcf.

6. LG&E's notice sets out a Performance-Based Rate ("PBR") Recovery Component of \$.0590 per Mcf, which will remain in effect to collect LG&E's portion of PBR savings until January 31, 2012.

7. LG&E's Gas Supply Cost Component ("GSCC") is \$.56050 per 100 cubic feet or \$5.6050 per Mcf, which is a decrease of \$.0093 per Mcf from the prior GSCC of \$5.6143 per Mcf.

8. The rate in the Appendix to this Order is fair, just, and reasonable, and should be approved for gas supplied by LG&E on and after August 1, 2011.

IT IS THEREFORE ORDERED that:

1. The rate in the Appendix, attached hereto and incorporated herein, is approved for gas supplied on and after August 1, 2011.

2. Within 20 days of the date of this Order, LG&E shall file its revised tariff sheets with this Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
