ORDER

On September 22, 2011, Garrard County Water Association, Inc. ("Garrard") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Garrard purchases water from the city of Lancaster ("Lancaster"), the city of Berea ("Berea") and the city of Danville ("Danville").
- 2. Berea notified Garrard that, effective November 10, 2011, Berea's wholesale water rate to Garrard will increase from \$2.17 per 1,000 gallons to \$2.50 per 1,000 gallons.
- 3. Garrard proposed a purchased water adjustment factor of \$0.04 per 1,000 gallons.
 - 4. Garrard proposed an effective date of November 10, 2011.

- 5. During the 12 months ending August 31, 2011, Garrard purchased 270,672,220 gallons of water from Lancaster, 30,827,324 gallons of water from Berea, 93,998,087 gallons of water from Danville, and sold 303,400,403 gallons of water. The increase in the cost of purchased water is \$10,173.02, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.
- 6. The purchased water adjustment factor of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Garrard's proposed rates are approved.
- 2. The purchased water adjustment factor of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are fair, just, and reasonable and are approved for services rendered on or after November 10, 2011.
- 4. Garrard's proposed tariff sheet filed with the application, showing the rates approved herein, is approved.
