ORDER

On January 29, 2010, in Case No. 2009-00492, the Commission approved Kentucky Frontier Gas, LLC's ("Kentucky Frontier") acquisition of the assets of People's Gas Company, Inc.¹ Upon completion of the acquisition, Kentucky Frontier d/b/a People's Gas Company, Inc. ("People's") adopted the tariff of People's, which included a Gas Cost Adjustment ("GCA") clause that provided for the adjustment of rates on a quarterly basis to reflect changes in the cost of purchased natural gas.

On September 29, 2011, People's filed its GCA to be effective November 1, 2011.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. People's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

- 2. People's notice sets out an Expected Gas Cost ("EGC") of \$6.7545 per Mcf, which represents an increase of \$.1965 per Mcf from its previous EGC of \$6.5580 per Mcf.
 - 3. People's notice sets out no current quarter Refund Adjustment.
- 4. People's notice sets out a current quarter Actual Adjustment ("AA") in the amount of \$.1384 per Mcf. People's total AA of \$.4075 per Mcf is an increase of \$.0338 per Mcf from its previous total AA of \$.3737 per Mcf.
- 5. People's notice proposes no current quarter Balance Adjustment ("BA"). People's total BA of (\$.0423) per Mcf represents a decrease of \$.0110 per Mcf from its previous total BA of (\$.0313) per Mcf.
- 6. People's GCA is \$7.1197 per Mcf, which is an increase of \$.2193 per Mcf from its previous GCA of \$6.9004 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for billing for service rendered by People's on and after November 1, 2011.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix attached hereto and incorporated herein are approved for billing for service rendered on and after November 1, 2011.
- 2. Within 20 days of the date of this Order, People's shall file its revised tariff sheets with this Commission setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
