### ORDER

On January 11, 2012, Big Sandy Water District ("Big Sandy") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Big Sandy purchases water from Cannonsburg Water District ("Cannonsburg"), the city of Kenova ("Kenova"), the city of Louisa ("Louisa"), and Rattlesnake Ridge Water District ("Rattlesnake Ridge").
- 2. Cannonsburg increased its wholesale water rate to Big Sandy from \$2.94 per 1,000 gallons to \$3.13 per 1,000 gallons, effective January 1, 2012.<sup>2</sup>
- 3. During the 12 months ending October 31, 2011, Big Sandy purchased 90,432,300 gallons of water from Louisa; 222,458,220 gallons of water from Kenova; 5,709,400 gallons of water from Rattlesnake Ridge; and 55,190,700 gallons of water from Cannonsburg. It sold 259,515,000 gallons of water during the same period. The increase in the cost of purchased water is \$10,486.23, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.

- 4. On December 19, 2011, Big Sandy's Board of Commissioners authorized an increase of \$0.04 in its rates for water service, effective January 1, 2012, which is commensurate with increase in Cannonsburg's wholesale rate.
- 5. Big Sandy's proposed rates are fair, just, and reasonable and should be approved.
- 6. The purchased water adjustment of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. Big Sandy's proposed rates are approved.
- 2. The purchased water adjustment of \$0.04 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for service rendered on or after January 1, 2012.
- 4. Within 20 days of the date of this Order, Big Sandy shall file revised tariff sheets with the Commission that reflect the rates approved in this Order and that are signed by an officer who is authorized to issue tariffs.
