## ORDER

On August 7, 2012, Ben Taylor and Sierra Club (collectively "Sierra Club") filed a motion seeking a one day extension to file its responses to the requests for information of Big Rivers Electric Corporation, Kentucky Industrial Utility Customers, Inc., and Commission Staff. Sierra Club points out that, pursuant to the Commission's Order of June 19, 2012, intervenors' responses to requests for information were due on or before August 6, 2012. In support of its motion for an extension, Sierra Club indicated that it hired a copy service in Frankfort, Kentucky to handle the filing of its discovery responses. However, the copy service was unable to print all of the requisite copies and deliver them to the Commission's offices by the scheduled deadline. Sierra Club notes that it was able to provide the discovery responses to the parties in this matter via electronic mail. Sierra Club requests a one-time extension of time to file the discovery responses and commits to making sure that such errors will not happen again in this matter.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Sierra Club has established good cause to permit it an extension of one day, or August 7, 2012, to file its discovery responses.

IT IS THEREFORE ORDERED that Sierra Club's motion for an extension of time to file its responses to the data requests of Big Rivers Electric Corporation, Kentucky Industrial Utility Customers, Inc., and Commission Staff is granted.
