ORDER

On May 31, 1996, in Case No. 1994-00433, the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's Gas Cost Adjustment ("GCA") clause.¹

On March 5, 2012, Bluegrass filed its proposed GCA to be effective April 1, 2012.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Bluegrass's notice sets out an Expected Gas Cost ("EGC") of \$5.3322 per Mcf, which is a decrease of \$.5437 per Mcf from its previous EGC of \$5.8759 per Mcf.

3. Bluegrass's notice sets out no current quarter Refund Adjustment.

4. Bluegrass's notice sets out a current quarter Actual Adjustment ("AA") of (\$.3335) per Mcf. Bluegrass's total AA is (\$.2775) per Mcf, which is a decrease of \$.2066 per Mcf from its previous total AA of (\$.0709) per Mcf.

5. Bluegrass's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0008) per Mcf. Bluegrass's total BA is \$.0159 per Mcf, which is a decrease of \$.0038 per Mcf from its previous total BA of \$.0197 per Mcf.

6. Bluegrass's GCA is \$5.0706 per Mcf, which is a decrease of \$.7541 per Mcf from its previous rate of \$5.8247 per Mcf.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Bluegrass on and after April 1, 2012.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered on and after April 1, 2012.

2. Within 20 days of the date of this Order, Bluegrass shall file with the Commission its revised tariffs setting out the rates approved herein, reflecting that they were approved pursuant to this Order.
