#### <u>ORDER</u>

On April 27, 2012, East Daviess County Water Association ("East Daviess") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. East Daviess purchases water from Owensboro Municipal Utilities ("Owensboro").

2. Owensboro notified East Daviess that, effective June 1, 2012, its volumetric wholesale rate to East Daviess will decrease from \$1.36 per 1,000 gallons to \$1.20 per 1,000 gallons.

3. East Daviess proposes a purchased water adjustment factor of (\$0.12) per 1,000 gallons.

4. During the 12 months ended March 31, 2012, East Daviess purchased 293,899,000 gallons of water from Owensboro and sold 246,075,202 gallons. The decrease in the cost of purchased water is (\$47,023.84) resulting in a purchased water

adjustment factor of (\$0.19) per 1,000 gallons. When calculating the purchased water adjustment factor, East Daviess used the incorrect number of gallons sold and obtained.

5. The purchased water adjustment factor of (\$0.19) per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The rates proposed by East Daviess are denied.

2. The purchased water adjustment factor of (\$0.19) per 1,000 gallons as calculated in Appendix A is approved.

3. The rates in Appendix B are fair, just, and reasonable and are approved for services on or after June 1, 2012.

4. Within 20 days of the date of this Order, East Daviess shall file with the Commission a revised tariff sheet showing the rates approved herein.
