ORDER

On April 27, 2012, Big Sandy Water District ("Big Sandy") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Big Sandy purchases water from Cannonsburg Water District, the city of Kenova ("Kenova"), the city of Louisa, and Rattlesnake Ridge Water District.
- 2. Kenova notified Big Sandy that, effective April 13, 2012, Kenova's wholesale water rate to Big Sandy would increase from \$1.79 per 1,000 gallons to \$2.55 per 1,000 gallons.
- 3. Big Sandy proposed to increase the water rates to its customers effective May 1, 2012.
- 4. During the 12 months ending February 29, 2012, Big Sandy purchased a total of 381,481,920 gallons of water, 226,563,220 of which were from Kenova, and sold 250,096,400 gallons. The increase in the cost of purchased water is \$172,188.05, resulting in a purchased water adjustment of \$0.69 per 1,000 gallons.

5. The purchased water adjustment of \$0.69 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Big Sandy's proposed rates are approved.
- 2. The purchased water adjustment of \$0.69 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are fair, just, and reasonable and are approved for service rendered on or after May 1, 2012.
 - 4. The tariff sheets filed by Big Sandy are approved as filed.
