ORDER

On June 8, 2012, Garrard County Water Association, Inc. ("Garrard County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Garrard County purchases water from the city of Lancaster ("Lancaster"), the city of Danville ("Danville"), and the city of Berea ("Berea").
- 2. Lancaster notified Garrard County that, effective with its July 10, 2012 billing, Lancaster's wholesale water rate to Garrard County would increase from \$2.01 per 1,000 gallons to \$2.03 per 1,000 gallons. Garrard County proposes to increase the water rates to its customers effective July 10, 2012.
- 3. During the 12 months ending April 30, 2012, Garrard County purchased 252,949,447 gallons of water from Lancaster, 98,876,242 gallons from Danville, and 29,186,960 gallons from Berea, for a total purchase of 381,012,649 gallons. It sold

293,741,700 gallons of water. The increase in the cost of purchased water is \$5,058.98, resulting in a purchased water adjustment of \$0.02 per 1,000 gallons.

4. The purchased water adjustment of \$0.02 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Garrard County are approved.
- 2. The purchased water adjustment of \$0.02 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service rendered on or after July 10, 2012.
 - 4. The tariff sheets filed by Garrard County are approved as filed.
