ORDER

On June 8, 2012, East Casey Water District ("East Casey") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. East Casey purchases water from the city of Liberty ("Liberty"), the city of Russell Springs ("Russell Springs"), the city of Campbellsville ("Campbellsville"), the city of Eubank ("Eubank") and Adair County Water District ("Adair County").

2. Liberty notified East Casey that, effective July 1, 2012, its volumetric wholesale rate to East Casey would increase from \$2.38 per 1,000 gallons to \$2.55 per 1,000 gallons.

3. East Casey proposed a purchased water adjustment factor of \$0.16 per 1,000 gallons.

4. During the 12 months ending April 30, 2012, East Casey purchased 199,341,000 gallons of water from Liberty, 43,552,500 gallons of water from Russell Springs, 16,385,800 gallons of water from Campbellsville, 347,100 gallons of water from Eubank and 4,246,300 gallons of water from Adair County. East Casey sold

209,106,600 gallons of water during the same 12 months. The increase in the cost of purchased water is \$33,887.97, resulting in a purchased water adjustment factor of \$0.16 per 1,000 gallons.

5. East Casey proposed an effective date of July 31, 2012.

6. The purchased water adjustment factor of \$0.16 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by East Casey are approved.

2. The purchased water adjustment factor of \$0.16 per 1,000 gallons as calculated in Appendix A is approved.

3. The rates in Appendix B are fair, just, and reasonable and are approved for service rendered on or after July 31, 2012.

4. East Casey's proposed tariff sheet filed with the application is approved.
