### <u>ORDER</u>

On April 29, 2004, in Case No. 2003-00411,<sup>1</sup> the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), and provided for their further adjustment on a quarterly basis in accordance with Equitable's Gas Cost Adjustment ("GCA") clause.

On June 20, 2012, Equitable filed its proposed GCA to be effective August 1, 2012.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Equitable's Expected Gas Cost ("EGC") is \$4.0277 per Mcf, which is a decrease of \$.3369 per Mcf from its previous EGC of \$4.3646 per Mcf.

3. Equitable's notice sets out a current quarter Actual Adjustment ("AA") of \$.0307 per Mcf. Equitable's total AA is (\$1.1908) per Mcf, which is an increase of \$.1735 per Mcf from the previous total AA of (\$1.3643) per Mcf.

4. Equitable's notice sets out a current quarter Balancing Adjustment ("BA") of (\$.0305) per Mcf. Equitable's total BA is (\$.0230) per Mcf, which is a decrease of \$.0379 per Mcf from the previous total BA of \$.0149 per Mcf.

5. Equitable's Gas Cost Recovery Rate is \$2.8139 per Mcf, which is a decrease of \$.2013 per Mcf from its previous rate of \$3.0152 per Mcf.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Equitable on and after August 1, 2012.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after August 1, 2012.

2. Within 20 days of the date of this Order, Equitable shall file its revised tariff sheets with this Commission setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
