#### ORDER

On July 2, 2012, Kirksville Water Association ("Kirksville") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Kirksville purchases water from Richmond Utilities ("Richmond").

2. On July 1, 2012, Richmond increased its wholesale water rate to Kirksville from \$2.17 per 100 cubic feet to \$2.24 per 100 cubic feet.

3. During the 12 months ending April 31, 2012, Kirksville purchased a total of 13,595,301 cubic feet (101,692,848 gallons) of water and sold 93,092,862 gallons. The increase in the cost of purchased water is \$9,516.71, resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.

4. The purchased water adjustment factor of \$0.10 per 1,000 gallons is fair, just, and reasonable and should be approved.

5. Kirksville's proposed rates are fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Kirksville are approved.

2. The purchased water adjustment factor of \$0.10 per 1,000 gallons as calculated in Appendix A is approved.

3. The rates in Appendix B are fair, just, and reasonable and are approved for service rendered on and after July 1, 2012.

4. Kirksville's proposed tariff sheet filed with the application is approved.
