ORDER

On July 19, 2012, Montgomery County Utilities District No. 1 ("Montgomery County") submitted an application for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Montgomery County purchases water from Mount Sterling Water and Sewer System ("Mount Sterling").
- 2. On August 1, 2012, Mount Sterling increased its volumetric wholesale rate to Montgomery County from \$2.34 per 1,000 gallons to \$2.41 per 1,000 Gallons.
- 3. Montgomery County proposed a purchased water adjustment factor of \$0.09 per 1,000 gallons.
- 4. During the 12 months ending May 31, 2012, Montgomery County purchased 39,320,265 gallons of water from Mount Sterling and sold 33,416,890 gallons of water during the same 12 months. The increase in the cost of

purchased water is \$2,752.42 resulting in a purchased water adjustment factor of \$0.09 per 1,000 gallons.

- 5. Montgomery County proposes to increase the water rates to its customers effective August 1, 2012.
- 6. The purchased water adjustment factor of \$0.09 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 7. Montgomery County's proposed rates, set forth in Appendix B to this Order, are fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

- 1. Montgomery County's proposed rates are approved.
- 2. The purchased water adjustment factor of \$0.09 per 1,000 gallons, as calculated in Appendix A, is approved.
- 3. The rates in Appendix B are fair, just, and reasonable and are approved for service rendered on or after August 1, 2012.
- 4. Montgomery County's proposed tariff sheet filed with the application is approved.
