ORDER

On December 29, 2009, in Case No. 2009-00202,¹ the Commission approved rates for Duke Energy Kentucky, Inc. ("Duke") and provided for their further adjustment in accordance with Duke's Gas Cost Adjustment ("GCA") clause.

On August 9, 2012, Duke filed its GCA to be effective August 29, 2012.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Duke's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Duke's Expected Gas Cost ("EGC") is \$4.682 per Mcf, which is a decrease of \$.071 per Mcf from its previous EGC of \$4.753 per Mcf.
- 3. Duke's notice sets out its current quarter Refund Adjustment ("RA") of (\$.014) per Mcf. Duke's total RA is (\$.017) per Mcf, which represents a decrease of \$.013 per Mcf from its previous total RA of (\$.004) per Mcf.

- 4. Duke's notice sets out its current quarter Actual Adjustment ("AA") of (\$.161) per Mcf. Duke's total AA is (\$.182) per Mcf, which represents an increase of \$.147 per Mcf from its previous total AA of (\$.329) per Mcf.
- 5. Duke's notice sets out its current quarter Balancing Adjustment ("BA") of (\$.005) per Mcf. Duke's total BA of \$.042 per Mcf represents a decrease of \$.006 per Mcf from its previous total BA of \$.048 per Mcf.
- 6. Duke's Gas Cost Recovery ("GCR") rate is \$4.525 per Mcf, which is an increase of \$.057 per Mcf from its previous GCR of \$4.468 per Mcf.
- 7. The rates as proposed by Duke and set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after August 29, 2012.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Duke and set forth in the Appendix to this Order are approved for final meter readings on and after August 29, 2012.
- 2. Within 20 days from the date of this Order, Duke shall file its revised tariffs with this Commission setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
