### ORDER

On August 17, 2012, Western Rockcastle Water Association ("Western Rockcastle") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Western Rockcastle purchases water from the city of Mount Vernon ("Mount Vernon"), the city of Brodhead ("Brodhead"), and Southern Madison Water District ("Southern Madison").
- 2. On August 17, 2012, Mount Vernon increased its wholesale water rate to Western Rockcastle from \$2.16 per 1,000 gallons to \$2.93 per 1,000 gallons.
- On August 14, 2012, Western Rockcastle increased the water rates to its customers, effective August 17, 2012, to reflect the increase in its purchased water cost.
- 4. During the 12 months ending June 30, 2012, Western Rockcastle purchased 272,448,600 gallons of water from Mount Vernon, 7,454,196 gallons from

Brodhead, and 6,397,100 gallons from Southern Madison, for a total purchase of 286,299,896 gallons. It sold 215,320,700 gallons of water. The increase in the cost of purchased water is \$209,785.42, resulting in a purchased water adjustment of \$0.97 per 1,000 gallons.

- 5. The purchased water adjustment of \$0.97 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 6. The rates in Appendix B are fair, just, and reasonable and should be approved for service rendered on or after August 17, 2012.

IT IS THEREFORE ORDERED that:

- 1. Western Rockcastle's proposed rates are approved.
- 2. The purchased water adjustment of \$0.97 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for service rendered on or after August 17, 2012.
  - 4. Western Rockcastle's tariff sheet is approved as filed.
