COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION TO  
BLUE GRASS ENERGY COOPERATIVE CORPORATION

Blue Grass Energy Cooperative Corporation ("Blue Grass Energy"), pursuant to 807 KAR 5:001, is to file with the Commission the original and ten copies of the following information, with a copy to all parties of record. The information requested herein is due no later than ten days from the date of issuance of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Blue Grass Energy shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or,


though correct when made, is now incorrect in any material respect. For any request to which Blue Grass Energy fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request.

1. Explain whether those customers who choose to participate in Blue Grass Energy's proposed SC-2 General Service Time of Day ("TOD") rate currently have the necessary metering and related equipment to provide the information needed for billing the new rate.

a. If new equipment will be required, what is the cost differential between Blue Grass Energy's standard meter and the new meter, including all associated equipment, that Blue Grass Energy intends to use for customers taking service under the proposed TOD Tariff? Include all necessary calculations needed to support the cost differential.

b. How does Blue Grass Energy propose recovering this cost differential, if any? Include whether there is any provision for recovery in the customer charge that Blue Grass Energy proposes.
