#### ORDER

On August 31, 2012, North Mercer Water District ("North Mercer") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- North Mercer purchases water from the city of Harrodsburg ("Harrodsburg").
- 2. Harrodsburg's wholesale water service rates to North Mercer are based upon a seven-step, declining block rate design.
- 3. On September 10, 2012, Harrodsburg increased its wholesale water rate to North Mercer, increasing each rate block, on average, by 12.5 percent.
- 4. North Mercer proposes to increase the water rates to its customers effective September 24, 2012 to reflect the increase in its wholesale supplier's rates.
- 5. During the 12 months ending August 31, 2012, North Mercer purchased a total of 308,065,530<sup>2</sup> gallons of water from Harrodsburg and sold 254,080,776 gallons.

The increase in the cost of purchased water is \$74,681.30, resulting in a purchased water adjustment of \$0.29 per 1,000 gallons.

- 6. The purchased water adjustment of \$0.29 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 7. North Mercer's proposed rates are fair, just, and reasonable and should be approved for service rendered on and after September 24, 2012.

#### IT IS THEREFORE ORDERED that:

- 1. North Mercer's proposed rates are approved.
- 2. The purchased water adjustment of \$0.29 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B are approved for service that North Mercer renders on or after September 24, 2012.
  - 4. North Mercer's proposed tariff sheet is approved.
