## ORDER

On October 11, 1993, in Case No. 1993-00111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's Gas Cost Adjustment ("GCA") clause.<sup>1</sup>

On August 31, 2012, Belfry filed its GCA to be effective October 1, 2012.

After reviewing the record in this case and being otherwise sufficiently advised,

the Commission finds that:

1. Belfry's notice includes revised rates designed to pass on to its customers

its expected change in wholesale gas costs.

2. Belfry's notice sets out an Expected Gas Cost ("EGC") of \$3.7276 per Mcf, an increase of \$.3297 per Mcf from its prior EGC of \$3.3979 per Mcf.

3. Belfry's notice sets out no Refund Adjustment.

4. Belfry's notice sets out a current quarter Actual Adjustment ("AA") of (\$.1174) per Mcf. Belfry's total AA is (\$1.1080) per Mcf, which is a decrease of \$.2035 per Mcf from its previous total AA of (\$.9045) per Mcf.

5. Belfry's notice sets out no Balance Adjustment.

6. Belfry's proposed GCA of \$2.6195 per Mcf contained a spread sheet calculation error. Belfry's corrected GCA of \$2.6196 per Mcf is an increase of \$.1262 per Mcf from its previous rate of \$2.4934 per Mcf.

7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered on and after October 1, 2012.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Belfry are denied.

2. The rates in the Appendix to this Order are approved for service rendered on and after October 1, 2012.

3. Within 20 days of the date of this Order, Belfry shall file its revised tariff sheets with the Commission setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
