On October 21, 2010, in Case No. 2010-00116,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On September 24, 2012, Delta filed its proposed GCA to be effective October 29, 2012.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$4.3119 per Mcf, which is a decrease of \$.9640 per Mcf from the previous EGC of \$5.2759 per Mcf.
- 3. Delta's notice sets out no current quarter Refund Adjustment ("RA"). Delta's total RA is (\$.1142) per Mcf, which is an increase of \$.0152 per Mcf from the previous quarter total RA of (\$.1294) per Mcf.

- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$.1662 per Mcf. Delta's total AA is \$1.3304 per Mcf, which is an increase of \$.2111 per Mcf from the previous total AA of \$1.1193 per Mcf.
- 5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.2272) per Mcf, which represents a decrease of \$2.0786 per Mcf from the previous BA of \$1.8514 per Mcf.
- 6. Delta's GCA is \$5.3009 per Mcf, which is a decrease of \$2.8163 per Mcf from the previous GCA of \$8.1172 per Mcf.
- 7. The GCA rates in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after October 29, 2012.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after October 29, 2012.
- 2. Within 20 days of the date of this Order, Delta shall file its revised tariff sheets with this Commission setting out the rates authorized herein and reflecting that they were approved pursuant to this Order.
