ORDER

On April 8, 2013, Clark Energy Cooperative, Inc. ("Clark") filed a motion for a 30-day extension of time for both parties to comply with the procedural schedule issued on March 13, 2013.

In support of its motion, counsel for Clark states that renewed settlement negotiations remain ongoing between the parties, and that in recent weeks Defendant has made an offer to the Complainant, the Complainant has made a counteroffer, and the Defendant has made a counteroffer to the Complainant. The motion states that because the Complainant and the Defendant are, or are governed by, a board of directors, meeting regularly only once a month due to the difficulties inherent in calling multiple special meetings of the boards, and because Complainant's next regular meeting is not until April 18, 2013, Clark believes the Commission should allow the settlement negotiation to proceed and should grant both parties at least 30 days from the date set forth in the March 13, 2013 Order by which to file either testimony or a

proposed Agreed Order of Settlement, if a settlement is reached. Clark requests that both parties be relieved from the procedural schedule in the March Order for at least 30 days so that settlement negotiations may proceed.

Based on the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted and that new procedural dates should be established. A new procedural schedule is set forth in the attached Appendix.

IT IS THEREFORE ORDERED that:

- 1. Clark's motion for a 30-day extension of time is granted.
- 2. The procedural schedule set forth in the attached Appendix shall be followed.
