## ORDER

On January 2, 2013, Kentucky Frontier Gas, LLC ("Frontier") filed a request to suspend the procedural schedule issued on December 13, 2012, eliminate the discovery provisions, that the intervenors be treated as limited intervenors for notification purposes only, and that the case be submitted for decision immediately.

On September 17, 2012, Joe and Gloria Conley (the "Conleys") requested to intervene in this case and on September 25, 2012, Salyersville First Baptist Church (the "Church") requested to intervene in this case. On December 13, 2012, the Commission issued orders granting full intervention to the Conleys and to the Church and amended the September 19, 2012 procedural schedule. On December 26, 2012, the Church requested that it be granted "informal intervention" rather than full intervention. The Conleys have not requested that their full intervention status be changed. Although neither the Conleys nor the Church have filed requests for information to Frontier as allowed for in the December 13, 2012 procedural schedule, the procedural schedule

allows the intervenors to file comments relating to Frontier's application until January 23, 2013.

The Commission, having reviewed the motion and being otherwise sufficiently advised, finds that Frontier's motion is premature and should be denied and that a hearing should be scheduled in this matter.

## IT IS THEREFORE ORDERED that:

- 1. Frontier's motions to suspend the procedural schedule issued on December 13, 2012, to eliminate the discovery provisions, to treat the Conley's as limited intervenors for notification purposes only, and to have the case be submitted for decision immediately are denied.
  - 2. The Church's motion for informal intervention is pending.
- 3. A hearing in this matter shall be held on Thursday, February 14, 2013, at 10:00 a.m. Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
  - 4. The official record of these proceedings shall be by video only.
- 5. Kentucky Frontier Gas, LLC shall publish notice of this hearing in compliance with 807 KAR 5:011, Section 8(5).
- 6. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
