ORDER

The Commission, on its own motion, HEREBY ORDERS that:

2. Issues to be discussed at the informal conference shall include, but not be limited to:

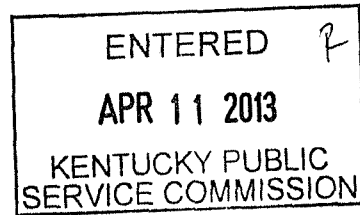
(a) The need for, and feasibility of, uniform standards for Smart Grid Investment and Smart Grid Information;

(b) A process for the identification of reasonable standards and programs for the implementation of Smart Grid Investment, Smart Grid Information, reliability improvements, and dynamic pricing; and


(c) The willingness of all parties to work in a collaborative manner to identify reasonable standards and programs consistent with a Smart Grid and the principles set forth in the Energy Independence and Security Act of 2007.

3. Each party shall have one or more representatives in attendance at the informal conference who are knowledgeable of all aspects of Smart Grid and the issues in this case, and who have authority to address procedural matters.
