On December 10, 2013, the Commission granted rehearing on one of the issues raised by the Attorney General of the Commonwealth of Kentucky, Ben Taylor and the Sierra Club, and Kentucky Industrial Utility Customers, Inc. in their November 20, 2013, petition for rehearing of our October 29, 2013, Order which granted Big Rivers Electric Corporation ("Big Rivers") an increase in annual revenues of \$54,227,241.
