ORDER

Hardin County Water District No. 1 ("Hardin District") has applied for approval to adjust its rates for sewer service. Finding that further proceedings are necessary to investigate the reasonableness of the proposed rates, the Commission establishes a schedule for review of the proposed rates.

IT IS THEREFORE ORDERED that:

- 1. The procedural schedule set forth in the Appendix to this Order shall be followed.
- 2. a. Responses to requests for information shall be appropriately indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.
- b. Each response shall be under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. A party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any request to which a party fails to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

e. The party responding to a request for information shall serve an original and a copy on the Commission and serve a copy upon all parties of record.

3. When Hardin District is required in this proceeding to provide notice of an event or filing pursuant to statute or administrative regulation, it shall forward a duplicate of the notice to the Commission.

4. At any hearing in this matter, neither opening statements nor summarization of written testimony shall be permitted.

5. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

6. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
