# ORDER

On February 12, 2013, Beech Grove Water System ("Beech Grove") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

Having reviewed the record and being sufficiently advised, the Commission finds that:

- Beech Grove purchases its water from the city of Henderson, Kentucky ("Henderson").
- 2. Henderson currently uses a four-step, declining block water rate schedule for its wholesale water sales to Beech Grove.
- 3. On March 1, 2013, Henderson adjusted its rates for wholesale water service to Beech Grove and increased by \$0.03 the charge for each rate block in the existing rate schedule.
- 4. Beech Grove proposes to adjust its rates for water service to its customer on April 1, 2013 to reflect the increase in its cost of purchased water.
- 5. During the 12 months ending December 31, 2012, Beech Grove purchased 54,972,138 gallons of water from Henderson and sold 50,136,650 gallons of water.

- 6. The increase in Henderson's wholesale rate for water service will increase Beech Grove's annual cost of purchased water by \$1,710.99.
- 7. As shown in Appendix A to this Order, a purchased water adjustment of \$0.04 per 1,000 gallons is necessary for Beech Grove to recover the increased purchased water cost.
- 8. Beech Grove's proposed purchased water adjustment of \$0.04 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 9. Beech Grove's proposed rates, which are set forth in Appendix B to this Order, reflect the application of a purchased water adjustment factor of \$0.04 per 1,000 gallons, are fair, just and reasonable, and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. Beech Grove's proposed purchased water adjustment of \$0.04 per 1,000 gallons is approved.
- 2. Beech Grove's proposed rates are approved for service rendered on and after April 1, 2013.
- 3. Beech Grove's tariff sheet, which was submitted with Beech Grove's application, is approved as filed.
