ORDER

On October 11, 1993, in Case No. 1993-00111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's Gas Cost Adjustment ("GCA") clause.¹

On March 1, 2013, Belfry filed its GCA to be effective April 1, 2013.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Belfry's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Belfry's notice sets out an Expected Gas Cost ("EGC") of \$4.6143 per Mcf, a decrease of \$.4973 per Mcf from its prior EGC of \$5.1116 per Mcf.
 - 3. Belfry's notice sets out no Refund Adjustment ("RA").
- 4. Belfry's notice sets out a current quarter Actual Adjustment ("AA") of \$.3905 per Mcf. Belfry's total AA is (\$.1725) per Mcf, which is an increase of \$.8942 per Mcf from its previous total AA of (\$1.0667) per Mcf.

- 5. Belfry's notice sets out no Balance Adjustment.
- 6. Belfry's GCA is \$4.4418 per Mcf, which is an increase of \$.3969 per Mcf from its previous rate of \$4.0449 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Belfry on and after April 1, 2013.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix, attached hereto and incorporated herein, are approved for service rendered on and after April 1, 2013.
- 2. Within 20 days of the date of this Order, Belfry shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
