#### ORDER

East Pendleton County Water District ("East Pendleton District") has applied to adjust its rates for water service. By this Order, the Commission approves rates that will produce annual water sales revenues of \$1,068,344, an increase of \$210,459 or 24.53 percent, over pro forma present rate revenues. Our action will increase the monthly bill of a residential customer who uses 5,000 gallons of water monthly from \$43.79 to \$55.74, or 27.29 percent.

On May 13, 2013, East Pendleton District applied for a rate adjustment pursuant to 807 KAR 5:076.<sup>1</sup> On June 28, 2013, after reviewing the application and East Pendleton District's records, Commission Staff issued a report containing its findings regarding the proposed rate adjustment. Commission Staff found that East Pendleton District's proposed rates would generate additional revenues of \$154,804 over proforma test-year revenues.<sup>2</sup> It further found that, using the approach that the Commission has historically employed to determine a water district's revenue requirements, East Pendleton District's financial condition would support a revenue

requirement from water sales of \$1,068,344 and, therefore, a revenue increase of \$210,456.<sup>3</sup> Commission Staff also recommended that the Commission direct East Pendleton District to revise its method for calculating and recording depreciation expense for accounting and ratemaking purposes and to revise its methods of allocating shared transactions between its water and sewer divisions.<sup>4</sup>

In response to this report, East Pendleton District advised the Commission that it accepted Commission Staff's findings regarding the need for a higher revenue requirement and the rates that Commission Staff found would generate the higher revenue requirement.<sup>5</sup> It further advised of its actions in response to Commission Staff's findings regarding East Pendleton District's internal controls and its agreement with Commission Staff's findings regarding the adjustment of the depreciable lives of certain assets.

On August 1, 2013, the Commission directed East Pendleton District to publish in a newspaper of general circulation in its territory notice of the Commission Staff's recommended rates and East Pendleton District's request that those rates be approved. East Pendleton District caused this notice to be published on August 6, 2013.<sup>6</sup> On September 15, 2013, having received no comments on East Pendleton District's request nor requests for intervention in this proceeding, the Commission closed the record and submitted the matter for decision.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. East Pendleton District, a water district organized pursuant to KRS Chapter 74, owns and operates facilities that distribute water to approximately 2,083 customers in Bracken, Campbell, Pendleton, and Harrison counties, Kentucky. It also owns sewage treatment and collection facilities that provide sewage service to 50 customers in Pendleton County, Kentucky.
- 2. The calendar year ending December 31, 2012, should be used as the test year to determine the reasonableness of East Pendleton District's existing and proposed rates.<sup>9</sup>
- 3. Based upon pro forma test-year operations, East Pendleton District's total pro forma revenue is \$886,088.<sup>10</sup>
- 4. Based upon pro forma test-year operations, East Pendleton District's total pro forma operating expenses, after adjusting for known and measurable changes, is \$925,696.<sup>11</sup>
- 5. The statement of East Pendleton District's test-period operations, as adjusted for known and measurable changes, is set forth in Appendix A of this Order.

- 6. East Pendleton District presently uses service lives for two classes of assets that are at variance<sup>12</sup> with those found in a survey of the National Association of Regulatory Utility Commissioners ("NARUC") that contained "a range of average service lives currently being used by water utilities throughout the country for water facilities designed and installed and maintained in accordance with good water works practice."<sup>13</sup>
- 7. The Commission has previously used the same survey to establish the service lives of utility assets.<sup>14</sup>
- 8. The record contains no evidence that the service lives that East Pendleton District uses are based upon a depreciation study or its own historic plant records.
- 9. East Pendleton District's assignment of service lives for these two classes of assets is not reasonable for ratemaking purposes and revisions in these assignments should be made for ratemaking and accounting purposes.<sup>15</sup>
- 10. Appendix B to this Order sets forth the classes of assets whose service lives should be adjusted, the previously assigned service life of each class, the service life range that the NARUC survey suggests for each class, and the assigned service life that should be used for ratemaking and accounting purposes for all future reporting periods.

These reassignments require a reduction of \$43,915 in East Pendleton District's test-period depreciation expense. Staff Report at 12-13.

11. As of December 31, 2012, East Pendleton District had outstanding long-term debt in the principal amount of \$1,363,100.<sup>16</sup> These debts and its outstanding principal amounts are set forth in Table 1.

- 12. In addition to the long-term debt listed in Table 1, East Pendleton District has executed an assistance agreement with Kentucky Infrastructure Authority ("KIA") to borrow \$160,000, which will be used to paint an elevated water storage facility. Debt service payments on this loan are known and measureable events that should be reflected in the calculation of East Pendleton District's annual debt service.
- 13. The three-year average of East Pendleton District's principal and interest payments on its existing long-term debt and its recent KIA loan is \$138,017.<sup>18</sup>
- 14. The Commission has historically used the Debt Service Coverage Methodology to calculate the revenue requirements of water districts with long-term debt.

- 15. Applying the Debt Service Coverage Methodology to East Pendleton District's pro forma operations results in a total revenue requirement from all revenue sources of \$1,096,547,<sup>19</sup> and an increase to water sales revenues of \$210,459.<sup>20</sup>
- 16. Based upon pro forma test-year sales, East Pendleton District's proposed rates will not produce annual revenues from water sales of \$1,068,344 or permit East Pendleton District to obtain total annual revenues of \$1,096,547.
- 17. Based upon pro forma test-year sales, the rates set forth in Appendix C to this Order will produce revenues from water sales of \$1,068,344 and will permit East Pendleton District to obtain total revenues of \$1,096,547.
- 18. The rates set forth in Appendix C are based upon a declining block rate design and more accurately reflect the differing demand ratios of the various meter sizes.
- 19. The rates set forth in Appendix C are fair, just, and reasonable and should be charged by East Pendleton District for service rendered on and after the date of this Order.
- 20. In its financial and statistical reports for its water and sewer operations for the year ending December 31, 2012, East Pendleton District failed to allocate shared transactions between its water and sewer divisions, but instead assigns the total expense or revenue to its water division. The failure to properly allocate such transactions results in the inaccurate reporting of East Pendleton District's financial condition.

21. East Pendleton District should revise its accounting procedures and internal controls to reasonably and fairly assign and allocate shared transactions between its water and sewer divisions.

#### IT IS THEREFORE ORDERED that:

- 1. East Pendleton District shall, for accounting and ratemaking purposes, use the "PSC Approved Service Life" set forth in Appendix B to this Order for the listed classes of assets when calculating and reporting depreciation for all reporting periods after the date of this Order, but shall make no retroactive adjustment to its books to account for the cumulative effect of this change in accounting estimate.
  - 2. East Pendleton District's proposed rates are denied.
- 3. East Pendleton District shall charge the rates set forth in Appendix C to this Order for water service rendered on and after November 16, 2013.<sup>21</sup>
- 4. Within 20 days of the date of this Order and using the Commission's Electronic Tariff Filing System, East Pendleton District shall file with the Commission revised tariff sheets that contain the rates set forth in Appendix C.
- 5. Within 90 days of the date of this Order, East Pendleton District shall revise its accounting procedures and internal controls to include methods and practices that reasonably and fairly allocate revenues and expenses between its water and sewer divisions and shall file with the Commission a copy of these revised procedures and controls and evidence of its Board of Commissioners' formal adoption of such procedures.

East Pendleton District requested that any rate adjustment be effective on the sixteenth of the month to coincide with its meter reading schedule. Letter of Wayne Lonaker to Public Service Commission (Mar. 13, 2013).

- 6. Any documents filed pursuant to ordering paragraph 5 shall reference this case number and shall be retained in the utility's general correspondence file.
- 7. The Executive Director is delegated authority to grant reasonable extensions of time for the filing of any documents required by this Order upon East Pendleton District's showing of good cause for such extension.
