ORDER

In an Order issued today in Case No. 2011-00443,<sup>1</sup> the Commission approved the consolidated Gas Cost Adjustment (“GCA”) clause of Kentucky Frontier Gas, LLC (“Frontier”), which replaces the individual GCA clauses of the Local Distribution Companies (“LDC”) Frontier had acquired. The Commission further authorized Frontier to use a system-wide weighted average cost of gas for the combined Frontier LDC system. Because the system-wide gas cost approved in Case No. 2011-00443 incorporates the individual gas costs of People’s Gas Company, Inc. (“People’s”), Mike Little Gas Company, Inc. (“Mike Little”), and Auxier Road Gas Company, Inc. (“Auxier”), the Commission finds that these applications should be dismissed. Any remaining under/over-recoveries of gas cost which have not been reconciled through the individual LDCs’ GCA tracking mechanisms shall be identified and recovered from or returned to

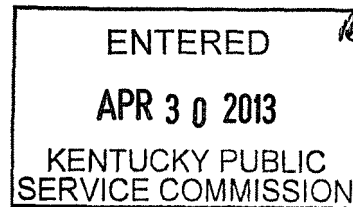

customers of the individual systems through future tracking mechanisms to be proposed by Frontier and approved by the Commission.

IT IS THEREFORE ORDERED that the rates proposed by People's, Mike Little, and Auxier are denied, and these cases are closed and are removed from the Commission's docket.
