ORDER

On April 10, 2013, Kentucky Power Company ("Kentucky Power") filed an application, pursuant to KRS 278.300, seeking, among other things, approval and authorization for Kentucky Power to enter into a Renewable Energy Purchase Agreement for Biomass Energy Resources with EcoPower Generation-Hazard LLC.

KRS 278.300(2) provides that the Commission shall have 60 days to adjudicate an application for authority to issue evidences of indebtedness unless it is necessary for good cause to continue the application. As the Commission does not expect to complete the investigation of Kentucky Power's application within 60 days, the Commission finds that good cause exists to continue the financing application beyond the 60-day period specified in KRS 278.300(2). The Commission further finds that a procedural schedule should be established for the processing of this matter.

IT IS HEREBY ORDERED that:

- 1. Kentucky Power's application for approval and authorization to enter into a Renewable Energy Purchase Agreement for Biomass Energy Resources with EcoPower Generation-Hazard LLC is continued beyond the 60-day period specified in KRS 278.300(2).
- 2. The procedural schedule set forth in the Appendix attached hereto and incorporated herein shall be followed.
- 3. a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record and an original and ten copies to the Commission.
- b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.
- c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.
- d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

- 4. All parties shall respond to any requests for information that Commission Staff submits in accordance with the procedural schedule set forth in the Appendix.
 - 5. Any party filing testimony shall file an original and ten copies.
- 6. At any public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.
- 7. The Commission does not look favorably upon motions for continuance. Consequently, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
- 8. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
