ORDER

On July 8, 2013, the Attorney General of the Commonwealth of Kentucky ("Attorney General"), by and through his Office of Rate Intervention, filed a motion requesting a modification of the procedural schedule to allow him a one-week extension, from July 12, 2013 to July 19, 2013, to submit his first round of discovery to Columbia Gas of Kentucky, Inc. ("Columbia Gas"). Additionally, the Attorney General asks that the entire procedural schedule be extended by one week so as not to prejudice the other parties involved. In support of his request, the Attorney General states that he has many cases before the Commission currently, and that scheduling conflicts have arisen. The Attorney General notes that Columbia Gas does not object to his request as long as the suspension of rates remains intact based on the date of filling. The Attorney General also avers that the other intervenors do not object to his motion.

Having reviewed the pleadings, and being otherwise sufficiently advised, the Commission finds that the Attorney General has established good cause to allow him an extension of time in which to file his first round of discovery.

IT IS THEREFORE ORDERED that:

- 1. The Attorney General's motion for an extension of time is granted to the extent that its first round of discovery shall be filed by July 19, 2013, and all subsequent procedural steps shall be extended by one week.
- 2. The procedural schedule attached as an Appendix to this Order shall be followed in this case and shall supersede the procedural schedule appended to the Commission's June 17, 2013 Order.
