## ORDER

The matter is before the Commission upon the petition of Office of Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention ("AG"), to file his notice of objection to the letter filed by Kentucky Industrial Utility Customers ("KIUC") on or about September 12, 2013, or, in the alternative, to amend the procedural schedule. The AG notes that the procedural schedule does not permit any intervenor to file rebuttal testimony, but points to KIUC's letter, in which KIUC states that "[it] will not file Direct Testimony in the above-referenced matter, but reserves the right to file Rebuttal to testimony of other intervenors."<sup>1</sup> The AG contends that since there is no date for intervenor rebuttal testimony. He also objects to KIUC's letter as being untimely, and notes that since KIUC did not file direct testimony, it waived its right to file rebuttal testimony. The AG further argues that if the Commission determines that KIUC is entitled to file rebuttal testimony, the AG should be afforded the opportunity to file sur-rebuttal testimony to KIUC.

On September 23, 2013, KIUC filed a memo in response to the AG's notice of objection to KIUC's letter. KIUC contends that there is nothing in the Kentucky Revised Code or the Kentucky Administrative Rules forbidding an intervenor from submitting testimony in response to another intervenor's testimony. KIUC further argues that it should be allowed to file rebuttal testimony in order to preserve the procedural due process rights of the Columbia Gas industrial customers that it represents and to provide additional information to the Commission. However, KIUC agrees that the AG should have the opportunity to file sur-rebuttal testimony to KIUC's rebuttal testimony.

Having reviewed the pleadings and being otherwise sufficiently advised, the Commission finds good cause to amend the procedural schedule.

IT IS THEREFORE ORDERED that:

1. The AG's petition to amend the procedural schedule is granted to the extent that all intervenors shall be permitted to file rebuttal testimony to other intervenors' direct testimony by October 16, 2013, sur-rebuttal testimony to other intervenors' rebuttal testimony by October 25, 2013, and Columbia shall be permitted to file rebuttal testimony by November 5, 2013.

2. The procedural schedule attached as the Appendix to this order shall be followed in this case and shall supersede the procedural schedule appended to the Commission's July 16, 2013 Order.
