ORDER

Adair County Water District ("Adair District") has applied for approval to execute an assistance agreement with Kentucky Rural Water Finance Corporation ("KRWFC") to borrow approximately \$4,025,000 to refund certain waterworks revenue bonds.¹

Having considered the record and being otherwise sufficiently advised, the Commission finds that:

- 1. Adair District, a water district organized pursuant to KRS Chapter 74, owns and operates facilities that distribute water to 7,668 customers in Adair County, Kentucky.²
- 2. Adair District proposes to execute an Assistance Agreement with KRWFC to borrow \$4,025,000 subject to an adjustment of up to 10 percent.³ The proposed loan

Adair District tendered its application to the Commission on April 30, 2013. In its application, it requested a deviation from 807 KAR 5:001, Section 17(2)(a). On May 14, 2013, the Commission granted this request and accepted the application for filing. No person or entity has sought intervention in this proceeding.

will have a term of 27 years and will accrue interest at a rate that ranges from 2.1 percent per annum to 4.15 percent per annum.⁴

- 3. Adair District proposes to use the proceeds from the assistance agreement to fully refund the outstanding bonds from 12 prior bond issuances,⁵ all of which Rural Development holds, and to pay fees and expenses incidental to the proposed loan.⁶ The bonds to be refunded are shown in Appendix to this Order.
- 4. Adair District estimates that the proposed refunding will result in total gross savings and net present value savings of \$551,207 and \$374,894 respectively.⁷
- 5. Adair District will expend \$4,264,742 to refund the outstanding bonds and to pay fees and expenses incidental to the proposed loan.⁸
- 6. Adair District's proposed assistance agreement with KRWFC is for a law-ful object within its corporate purpose, is reasonably necessary and appropriate for and consistent with the proper performance of its service to the public, will not impair Adair District's ability to perform that service, and is reasonably necessary and appropriate for such purpose.

IT IS THEREFORE ORDERED that:

- 1. Adair District is authorized to execute the proposed assistance agreement with KRWFC to borrow no more than \$4,427,500⁹ for the purpose of refunding the bonded debt listed in the Appendix to this Order, but only under such terms and conditions as will produce both positive gross savings and net present value savings.
- 2. If the actual terms and conditions of the agreement with KRWFC differ from those set forth in its application, Adair District shall, within 30 days of executing the loan agreement, file with the Commission amortization schedules and work papers showing the actual gross savings and net present value savings that will result from the proposed transaction.
- 3. Within 30 days of executing the proposed agreement, Adair District shall file a copy of the executed assistance agreement and any documents referenced in the executed assistance agreement that Adair District has not previously filed with the Commission.
- 4. The proceeds resulting from the assistance agreement shall be used only for the lawful purposes specified in Adair District's application.
- 5. Any documents filed pursuant to ordering paragraphs 2 and 3 of this Order shall reference the number of this case and shall be retained in the utility's general correspondence file.
