Wood Creek Water District has applied for an adjustment of its rates for service pursuant to the procedures set forth in 807 KAR 5:076. Finding that a procedural schedule should be established to ensure the orderly review of Wood Creek Water District's application, the Commission HEREBY ORDERS¹ that:

1. No later than July 22, 2013, Commission Staff shall file and serve upon all parties of record a written report containing its findings and recommendations regarding Wood Creek Water District's requested rate adjustment.

2. No later than August 5, 2013, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party of record shall file with the Commission:

a. Its written comments on and any objections to the findings and recommendations contained in the Commission Staff Report;

b. Any additional evidence for the Commission's consideration; and

c. Written notice as to whether this matter may be submitted for decision based upon the existing record without hearing.

¹ No action is necessary to suspend the effective date of Wood Creek Water District's proposed rates for general water service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set forth in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

3. If Commission Staff finds that Wood Creek Water District's financial condition supports a higher rate than Wood Creek Water District proposes or the assessment of an additional rate or charge not proposed in Wood Creek Water District's application, Wood Creek Water District in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge.

4. If Commission Staff recommends changes in the manner in which Wood Creek Water District accounts for the depreciation of Wood Creek Water District's assets, Wood Creek Water District in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should require Wood Creek Water District to implement the proposed change for accounting purposes.

5. A party's failure to file written objections to a finding or recommendation contained in the Commission Staff Report by August 5, 2013, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, shall be deemed as agreement with that finding or recommendation.

6. Unless all parties request that this matter be submitted for decision upon the existing record, an informal conference shall be held in this matter on August 12, 2013 at 1:00 p.m., Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

7. Unless all parties request that this matter be submitted for decision upon the existing record, a formal hearing in this matter shall be held in the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, at a date and time to be subsequently announced.


8. Each party shall file with the Commission, no later than August 19, 2013, a list of the persons it intends to call as witnesses at the scheduled hearing and a summary of each witness's expected testimony.

9. Wood Creek Water District shall publish notice of the scheduled hearing in accordance with 807 KAR 5:076, Section 11, no more than 21 days and no less than 7 days before the day of the scheduled hearing.

10. Pursuant to KRS 278.360, the record on the formal hearing in this matter shall be by videotape.

11. Commission Staff shall prepare a written list of all exhibits presented at the hearing and shall file this list with the Commission with all hearing exhibits and a copy of the video transcript of the hearing.
