#### ORDER

On May 22, 2013, Northeast Woodford Water District ("Northeast Woodford") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Northeast Woodford purchases water from the city of Versailles ("Versailles").

2. On July 1, 2013, Versailles's wholesale rate to Northeast Woodford increased from \$2.26 per 1,000 gallons to \$2.33 per 1,000 gallons.<sup>2</sup>

3. Northeast Woodford proposes to increase its water rates to its customers effective July 1, 2013.

4. During the 12 months ending March 31, 2013, Northeast Woodford purchased a total of 150,131,200 gallons of water and sold 124,579,000 gallons.

5. The increase in the cost of purchased water is \$10,509.19, resulting in a purchased water adjustment factor of \$0.08 per 1,000 gallons.

6. The purchased water adjustment of \$0.08 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

7. Northeast Woodford's proposed rates, which are set forth in Appendix B, are fair, just and reasonable.

IT IS THEREFORE ORDERED that:

1. Northeast Woodford's proposed adjustment of \$0.08 per 1,000 gallons is approved for water service rendered on and after July 1, 2013.

2. Northeast Woodford's proposed rates are approved.

3. Northeast Woodford's proposed tariff sheets, which were submitted with its application, are approved as filed.
