### ORDER

On May 29, 2013, North Shelby Water Company ("North Shelby") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- North Shelby purchases water from Louisville Water Company ("Louisville Water"), Frankfort Electric & Water Plant Board, Shelbyville Municipal Water & Sewer Commission, and West Shelby Water District.
- 2. On July 1, 2013, Louisville Water increased its monthly service charge to North Shelby from \$541.80 to \$593.60 per month and its volumetric wholesale rate to North Shelby from \$1.69 per 1,000 gallons to \$1.75 per 1,000 gallons.<sup>2</sup>
- North Shelby adjusted the water rates to its customers effective July 1,
   2013 to reflect the increased cost of purchased water.

- 4. During the 12 months ending March 31, 2013, North Shelby purchased a total of 260,220,000 gallons of water from Louisville Water and sold 370,856,300 gallons.
- 5. The increase in the cost of purchased water is \$16,234.80, resulting in a purchased water adjustment factor of \$0.05 per 1,000 gallons.
- 6. The purchased water adjustment of \$0.05 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 7. North Shelby's proposed rates, which are set forth in Appendix B, are fair, just and reasonable.

IT IS THEREFORE ORDERED that:

- 1. North Shelby's proposed adjustment of \$0.05 per 1,000 gallons is approved for water service rendered on and after July 1, 2013.
  - 2. North Shelby's proposed rates are approved.
- 3. North Shelby's proposed tariff sheets submitted with its application are approved as filed.
