ORDER

On May 12, 1993, in Case No. 1992-00331, the Commission approved rates for Western Lewis-Rectorville Water and Gas District ("Western Lewis") and provided for their further adjustment in accordance with Western Lewis Gas Cost Adjustment ("GCA") clause.¹

On May 30, 2013, Western Lewis filed its proposed Gas Cost Recovery Rate ("GCR") to be effective July 1, 2013.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Western Lewis's notice includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Western Lewis's notice sets out an Expected Gas Cost ("EGC") of \$6.0042 per Mcf, which is an increase of \$.3145 per Mcf from its previous EGC of \$5.6897 per Mcf.
 - 3. Western Lewis's notice sets out no Refund Adjustment.

- 4. Western Lewis's notice sets out a current quarter AA of \$(.5338) per Mcf. Western Lewis's total AA is (\$.6147) per Mcf, which is an increase of \$.1683 per Mcf from the previous total AA of (\$.7830) per Mcf.
- 5. Western Lewis's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0198) per Mcf. Western Lewis's total BA is (\$.1591) per Mcf, which is an increase of \$.0690 per Mcf from the previous total BA of (\$.2281) per Mcf.
- 6. Western Lewis's GCR is \$5.2304 per Mcf, which is an increase of \$.5518 per Mcf from the previous rate of \$4.6786 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Western Lewis on and after July 1, 2013.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for service rendered on and after July 1, 2013.
- 2. Within 20 days of the date of this Order, Western Lewis shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
