ORDER

On June 13, 2013, Jessamine County Water District No. 1 ("Jessamine County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Jessamine County purchases water from the city of Nicholasville ("Nicholasville").
- 2. On July 1, 2013, Nicholasville increased its volumetric wholesale rate to Jessamine County from \$2.73 per 1,000 gallons to \$2.81 per 1,000 gallons² due to an increase in the Kentucky River Authority Water User Fee.³
- 3. Jessamine County proposes to place the proposed rates into effect July 15, 2013.
- 4. Jessamine County proposes a purchased water adjustment factor of \$0.10 per 1,000 gallons.

- 5. During the 12 months ending April 30, 2013, Jessamine County purchased 226,753,800 gallons of water from Nicholasville, and sold 180,082,120 gallons of water. The increase in the cost of purchased water is \$18,140.31, resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.
- 6. The purchased water adjustment factor of \$0.10 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.10 per 1,000 gallons is approved.
- 2. The rates set forth in Appendix B to this Order are approved for services rendered on or after July 15, 2013.
- 3. Within 20 days of the date of this Order, Jessamine County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein, with the July 15, 2013 effective date.
