ORDER

On June 17, 2013, Reid Village Water District ("Reid Village") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Reid Village purchases water from the city of Mount Sterling ("Mount Sterling").

Mount Sterling increased its volumetric wholesale rate to Reid Village from
\$2.41 per 1,000 gallons to \$2.46 per 1,000 gallons on July 1, 2013.²

3. On July 1, 2013, Reid Village adjusted its rates to reflect the increase in purchased water costs due to Mount Sterling's rate adjustment.

Reid Village proposes a purchased water adjustment factor of \$0.06 per
1,000 gallons.

5. During the 12 months ending April 30, 2013, Reid Village purchased 64,454,660 gallons of water from Mount Sterling, and sold 58,011,477 gallons of water.

The increase in the cost of purchased water is \$3,222.73, resulting in a purchased water adjustment factor of \$0.06 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.06 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.06 per 1,000 gallons is approved.

2. Reid Village's proposed rates, as set forth in Appendix B to this Order, are approved for service that Reid Village renders on or after July 1, 2013.

3. Within 20 days of the date of this Order, Reid Village shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
