1. The motion of Hickman County Fiscal Court to intervene is granted.

2. Hickman County Fiscal Court shall be entitled to the full rights of a party and, pursuant to 807 KAR 5:001, Section 8, shall be served with electronic notice of the issuance of all Commission Orders issued after the date of this Order and of all documents filed by any party to this proceeding.


3. Within seven days of the date of this Order, Hickman County Fiscal Court shall file with the Commission a written statement that it waives any right to service of
