# COMMONWEALTH OF KENTUCKY BEFORE THE PUBLIC SERVICE COMMISSION

### ORDER

On July 5, 2011, in Case No. 2011-00010,<sup>1</sup> the Commission approved rates for Valley Gas, Inc. ("Valley Gas") and provided for their further adjustment on a quarterly basis in accordance with Valley Gas's Gas Cost Recovery ("GCR") clause.

On June 27, 2013, Valley Gas filed its GCR to be effective July 1, 2013.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Valley Gas's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Valley Gas's proposed Expected Gas Cost ("EGC") is \$5.1543 per Mcf, which is an increase of \$.6877 per Mcf from the previous EGC of \$4.4666 per Mcf.
  - 3. Valley Gas's notice sets out no current quarter Refund Adjustment.
- 4. Valley Gas's notice sets out a current quarter Actual Adjustment ("AA") of (\$.2890) per Mcf. Valley Gas's total AA is (\$1.7345) which is a decrease of \$.2247 per Mcf from the previous total AA of (\$1.5098) per Mcf.

- 5. Valley Gas's notice sets out a GCR of \$3.4199 per Mcf. Due to a spreadsheet error, Valley Gas did not calculate the GCR correctly. Correcting this produces a GCR of \$3.4198 per Mcf, which is an increase of \$.4630 per Mcf from the previous GCR of \$2.9568 per Mcf.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Valley Gas on and after July 27, 2013. Valley Gas did not give the 30 days' notice required for its increase in rates to be effective July 1, 2013.

#### IT IS THEREFORE ORDERED that:

- 1. The rate proposed by Valley Gas is denied.
- 2. The rate in the Appendix attached hereto and incorporated herein is approved for billing for service rendered on and after July 27, 2013.
- 3. Within 20 days of the date of this Order, Valley shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
