## ORDER

On July 24, 2013 Peaks Mill Water District ("Peaks Mill") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. ${ }^{1}$

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Peaks Mill purchases water from Frankfort Plant Board ("Frankfort") and Kentucky American Water Company ("Kentucky-American").
2. On July 28, 2013, Frankfort increased the Kentucky River Authority fee portion of its wholesale water rate to Peaks Mill from $\$ 0.1079$ per 1,000 gallons to $\$ 0.20$ per 1,000 gallons. ${ }^{2}$
3. During the 12 months ended May 31, 2013, Peaks Mill purchased $90,196,200$ gallons of water from Frankfort, 718,500 gallons of water from KentuckyAmerican and sold 57,997,900 gallons.
4. The increase in Peaks Mill's cost of purchased water is $\$ 8,307.07$, resulting in a purchased water adjustment factor of $\$ 0.14$ per 1,000 gallons.

[^0]5. On July 28, 2013, Peaks Mill increased its rates for water service to reflect its increased cost of purchased water.
6. The purchased water adjustment factor of $\$ 0.14$ per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
7. Peaks Mill's proposed rates for water service are fair, just, and reasonable and should be approved for service rendered on or after July 28, 2013.

IT IS THEREFORE ORDERED that:

1. The proposed purchased water adjustment factor of $\$ 0.14$ per 1,000 gallons is approved.
2. Peaks Mill's proposed rates, which are set forth in Appendix $B$ to this Order, are approved for water service that Peaks Mill renders on or after July 28, 2013.
3. Within 20 days of the date of this Order, Peaks Mill shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the approved rates.
