ORDER

On October 31, 2008, in Case No. 2008-00032,¹ the Commission approved rates for Burkesville Gas Company, Inc. ("Burkesville") and provided for their further adjustment on a monthly basis in accordance with Burkeville's Gas Cost Adjustment ("GCA") clause.

On August 27, 2013, Burkesville filed its proposed GCA with a proposed effective date of September 27, 2013.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Burkesville's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Burkesville's proposed EGC is \$8.3294 per Mcf, which is an increase of \$.1806 per Mcf from the prior EGC of \$8.1488 per Mcf.
 - 3. Burkesville's notice sets out no Refund Adjustment.
- 4. Burkesville's notice sets out a current Actual Adjustment ("AA") of (\$.0524) per Mcf. Due to a spread sheet error, Burkesville miscalculated its June 2013 Unit Cost

of Gas. Correcting this produces a current quarter AA of (\$.0527) per Mcf. Burkesville's corrected total AA is \$.1807 per Mcf, which represents a decrease of \$.0527 per Mcf from the previous total AA of \$.2334 per Mcf.

- 5. Burkesville's GCA is \$8.5101 per Mcf, which is an increase of \$.1279 per Mcf from the previous GCA of \$8.3822 per Mcf.
- 6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Burkesville on and after September 27, 2013.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Burkesville are denied.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are approved for service rendered on and after September 27, 2013.
- 3. Within 20 days of the date of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
