ORDER

On August 30, 2013, LaRue County Water District No. 1 ("LaRue County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. LaRue County purchases water from the cities of Bardstown ("Bardstown"), Hodgenville, and Campbellsville, Green River Valley Water District, and Green-Taylor Water District.
- 2. On September 1, 2013, Bardstown increased its wholesale rate to LaRue County from \$1.70 per 1,000 gallons to \$2.00 per 1,000 gallons.²
- 3. LaRue County increased the water rates to its customers on September 1, 2013 to reflect the increased cost of water purchased from Bardstown.³
- 4. During the 12 months ending July 31, 2013, LaRue County purchased a total of 179,203,840 gallons of water, 46,702,130 of which were purchased from

Bardstown, and sold 157,236,250 gallons.

- 5. The increase in the cost of purchased water is \$14,010.64, resulting in a purchased water adjustment factor of \$0.09 per 1,000 gallons.
- 6. The purchased water adjustment of \$0.09 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 7. LaRue County's proposed rates, which are set forth in Appendix B, are fair, just and reasonable.

IT IS THEREFORE ORDERED that:

- 1. LaRue County's proposed adjustment of \$0.09 per 1,000 gallons is approved for water service rendered on and after September 1, 2013.
 - 2. LaRue County's proposed rates are approved.
- 3. Within 20 days of the date of this Order, LaRue County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
