#### ORDER

On September 16, 2013, McKinney Water District ("McKinney") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. McKinney purchases water from the cities of Stanford ("Stanford") and Eubank ("Eubank").
- 2. On September 1, 2013, Stanford increased its wholesale water volumetric rate to McKinney from \$2.04 per 1,000 gallons to \$2.49 per 1,000 gallons.<sup>2</sup>
- 3. On September 14, 2013, McKinney adjusted its rates to reflect the increase in its cost of purchased water.
- 4. During the 12 months ended July 31, 2013, McKinney purchased 85,395,000 gallons of water from Stanford and 25,288,700 gallons of water from Eubank. It sold 89,097,600 gallons of water during the same period.
- 5. McKinney's adjusted rates are based upon a purchased water adjustment factor of \$0.43 per 1,000 gallons.

- 6. McKinney incorrectly calculated the purchased water factor. A purchased water adjustment factor of \$0.44, as calculated in Appendix B to this Order, is the correct factor.
- 7. A purchased water adjustment factor of \$0.44 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 8. The rates set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service that McKinney renders on and after September 14, 2013.

### IT IS THEREFORE ORDERED that:

- 1. McKinney's proposed rates are denied.
- 2. The purchased water adjustment factor of \$0.44 per 1,000 gallons is approved.
- 3. The rates set forth in Appendix B are approved for water service that McKinney renders on or after September 14, 2013.
- 4. Within 20 days of the date of this Order, McKinney shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the approved rates and an effective date of September 14, 2013.
