ORDER

On November 14, 2013, Jessamine-South Elkhorn Water District ("Jessamine-South Elkhorn") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Jessamine-South Elkhorn purchases water from Kentucky-American

 Water Company ("Kentucky-American").
- 2. On July 27, 2013, Kentucky-American increased its service charge rate of its metering locations to Jessamine-South Elkhorn from \$489.50 per month to \$684.75 per month and from \$142.40 per month to \$193.20 per month and decreased its wholesale water volumetric rate from \$4.20933 per 1,000 gallons to \$4.20930 per 1,000 gallons.²
- 3. Jessamine-South Elkhorn's application contained a mathematical error in the computation of the proposed purchase water factor. The correct purchase water

factor, as reflected in the calculations shown in Appendix A to this Order, is \$0.02 per thousand gallons.

- 4. On November 5, 2013, Jessamine-South Elkhorn adjusted its rates to reflect the increase in Kentucky-American's wholesale rates.
- 5. During the 12 months ended September 30, 2013, Jessamine-South Elkhorn purchased 218,490,490 gallons of water from Kentucky-American and sold 186,819,440 gallons of water.
- 6. A purchased water adjustment factor of \$0.02 per 1,000 gallons is fair, just, and reasonable and should be approved.
- 7. The rates set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service that Jessamine-South Elkhorn renders on and after November 5, 2013.

IT IS THEREFORE ORDERED that:

- 1. Jessamine-South Elkhorn's proposed rates are denied.
- 2. The purchased water adjustment factor of \$0.02 per 1,000 gallons is approved.
- 3. The rates in Appendix B are approved for service that Jessamine-South Elkhorn renders on or after November 5, 2013.
- 4. Within 20 days of the date of this Order, Jessamine-South Elkhorn shall file with the Commission, using the Commission's Electronic Tariff Filing System, revised tariff sheets showing the approved rates, with an effective date of November 5, 2013.
