ORDER

The Commission, on its own motion, HEREBY ORDERS that Stand Energy Corporation ("Stand Energy") be given additional time, until March 14, 2014, in which to file a brief in this matter. Although the original deadline for the parties to file briefs was February 25, 2014, the Commission has been made aware of circumstances that support granting additional time to Stand Energy. Specifically, Stand Energy did not receive a DVD of the official transcript of the January 23, 2014 public hearing until February 26, 2014.

On January 28, 2014, the Commission mailed Stand Energy a DVD of what was believed at the time to contain only the public portion of the official transcript of the January 23, 2014 hearing. On January 29, 2014, the official transcript of the public portion of the hearing was filed in the electronic case file and was thus available to the public at that time. On January 30, 2014, it was discovered that the DVD of the official transcript of the hearing that had been mailed to Stand Energy had inadvertently contained confidential information. Because Stand Energy had not signed a confidentiality agreement with Atmos Energy Corporation ("Atmos Energy"), it was not entitled to receive confidential information. When this was discovered, Commission

Staff contacted counsel for Stand Energy, telephonically and through a follow-up email, ¹ to discuss the error that had occurred. Counsel for Stand Energy informed Commission Staff that the DVD had not yet been received by Stand Energy, but agreed to return the unopened envelope containing the DVD to the Commission when it was received. ² From January 30, 2014, to February 24, 2014, several emails were exchanged between Commission Staff and Stand Energy regarding this DVD. On February 24, 2014, the U.S. Postal Service returned the envelope which had contained the DVD sent to Stand Energy. The returned envelope was visibly damaged and did not contain the DVD. Photocopies of the front and back of this envelope are attached hereto as Appendix A.

On February 24, 2014, Commission Staff mailed a replacement DVD to Stand Energy which did not contain confidential information. On February 25, 2014, Stand Energy informed Commission Staff that the replacement DVD had not yet been received and noted that additional time would be needed to prepare and file its brief in this matter.³ Commission Staff responded to this request and recommended that a motion be filed.⁴ On February 26, 2014, Stand Energy notified Commission Staff that the deadline for filing briefs had passed and that it still had not received the replacement

DVD.⁵ In a later email sent that same day, Stand Energy informed Commission Staff that the replacement DVD had been received.⁶

On February 26, 2014, Commission Staff notified Stand Energy that it would recommend to the Commission that Stand Energy's deadline for filing its brief be extended to March 14, 2014.⁷ On February 27, 2014, Stand Energy responded to Commission Staff and indicated that it would file its brief by March 14, 2014.⁸ Also on February 27, 2014, the Attorney General ("AG")⁹ and Atmos Energy¹⁰ expressed concerns about extending the deadline for Stand Energy and requested that they be given the opportunity to respond to Stand Energy's brief. Copies of the correspondence between Commission Staff and the parties, as detailed above, are collectively attached hereto and incorporated herein as Appendix B.

Based on a review of the above and being otherwise sufficiently advised, the Commission finds that, although the official public transcript of the January 23, 2014 hearing in this matter has been available to the public on the Commission's Web site since January 29, 2014, Stand Energy should nonetheless be granted additional time to

prepare and file its brief in this matter, subsequent to its receipt of the replacement DVD on February 26, 2014. The Commission also finds that the AG and Atmos Energy should be given an opportunity to respond to Stand Energy's brief.

IT IS THEREFORE ORDERED that:

- 1. Stand Energy is granted additional time, until March 14, 2014, to file a brief in this matter.
- 2. The AG and Atmos Energy shall have until March 21, 2014, to respond to Stand Energy's brief.
- 3. All other provisions of the Commission's prior Orders in this case shall remain in effect.

To all:

The OAG has observed the exchanges between Stand and the PSC. However, to date, we have not found the need to participate. At this time, and as best as I can determine, Stand will be allowed to file a brief after the time ordered for briefing in Atmos Case No. 2013-00148. If that is the situation, this may raise concerns for the OAG based on the following:

- The Commission speaks through its orders.
- No motion to amend, alter, or modify the procedural schedule has been filed to extend the time for the filing of briefs
- No order has been granted to allow an amendment, alteration or modification to the procedural order –
 including an enlargement of time to file briefs.
- The AG and Atmos have filed their briefs.
- An order granting an enlargement of time after the AG and Atmos have filed their briefs could prejudice them.
- Accordingly, if Stand is allowed to file a brief after the time heretofore established by the Commission, the AG
 and Atmos should be allowed to file responsive briefs to address Stand's brief only, if the parties so elect, and
 not address any other issues. Stated another way, the AG and Atmos should not be afforded the opportunity
 to file reply briefs to each other.
- Atmos has implemented its rates. While the rates are subject to refund, further delay in this proceeding will
 only complicate matters for the costumers.
