<u>ORDER</u>

On March 23, 2014, Water Service Corporation of Kentucky ("WSKY") moved for permission for Helen Lupton, Regional Vice President of Utilities, Inc., to testify via telephone or video conference at the April 9, 2014 hearing. In support of its motion, WSKY states that Ms. Lupton is located in the Charlotte, North Carolina, office. She recently gave birth, and at the time of the scheduled hearing, the infant will be too young to travel long distances. WSKY anticipates that the cross-examination for Ms. Lupton will be short.

Having considered the motion, the Commission finds that:

- 1. Due to the unique facts presented here, WSKY's motion for Ms. Lupton to testify via telephone or video conference should be granted.
- 2. A video conference system that is Internet Protocol compatible with the H.323 industry standard is necessary for a video conference during the hearing.

IT IS THEREFORE ORDERED that:

- WSKY's motion for Ms. Lupton to testify via telephone or video conference is granted.
- 2. Within seven days of entry of this Order, WSKY shall notify the Commission if WSKY has a video conference system that is Internet Protocol

compatible with the H.323 industry standard so that a video conference can occur. If WSKY does not have the appropriate video conference equipment, Ms. Lupton shall testify telephonically.
