## ORDER

On April 3, 2014, Water Service Corporation of Kentucky ("WSKY") moved to substitute Dimitry Neyzelman for Lowell Yap as a witness. Mr. Yap filed testimony and responded to requests for information. Mr. Neyzelman did not file testimony but filed a joint response to two items on a request for information filed by the Attorney General.

In support of its motion, WSKY states that Mr. Lowell is no longer employed by Utilities, Inc. (WSKY's parent company) effective April 2, 2014. Mr. Neyzelman was Mr. Yap's supervisor and that Mr. Neyzelman has participated in the preparation of Mr. Yap's prefiled testimony and responses to requests for information. WSKY also states that Mr. Neyzelman has access to corporation salary information, while Mr. Yap does not have knowledge of such information, and that Mr. Neyzelman has the knowledge necessary to respond to cross-examination questions. WSKY further states that it will not change its position on any issue due solely to a substitution of witnesses.

Having considered the motion, the Commission finds that the motion for substitution of a witness should be granted.

## IT IS THEREFORE ORDERED that:

 WSKY's motion to substitute Dimitry Neyzelman as a witness for Lowell Yap is granted. 2. WSKY shall ensure that its witnesses are prepared to respond to cross-examination questions regarding Lowell Yap's testimony and responses to requests for information.
