## ORDER

On August 4, 2014, Louisville Gas and Electric Company and Kentucky Utilities Company (collectively "Joint Movants") filed a motion requesting an extension of the abeyance of the procedural schedule in this case until after the August 12, 2014 informal conference. In support of their motion, Joint Movants note that, pursuant to the Commission's May 5, 2014 Order, the procedural schedule is currently held in abeyance for a 90-day period. Because the August 12, 2014 informal conference fell outside the abeyance of the procedural schedule, Joint Movants, out of an abundance of caution and to ensure no timing complications in the procedure of this matter, request that the 90-day abeyance period be extended until after the August 12, 2014 informal conference. Joint Movants assert that an extension of the abeyance period would also allow the Commission to establish a revised procedural schedule after receiving information from the parties regarding the outstanding issues in the case.
