## <u>ORDER</u>

This matter arises upon the motion of Wallace McMullen and Sierra Club (collectively "Sierra Club") filed March 13, 2014, requesting a three-day extension to file supplemental requests for information that are due to be filed no later than March 17, 2014. As grounds for its request, Sierra Club states that on March 12, 2014, it received Louisville Gas and Electric Company's and Kentucky Utilities Company's ("LG&E/KU") responses to Sierra Club's initial set of requests for information, and has not had enough time to review the responses. Sierra Club states that the Commission's Order of January 30, 2014, established a procedural schedule which required responses to initial requests for information to be filed no later than March 3, 2014, but that Sierra Club was not granted intervention until March 12, 2014, the same day LG&E/KU filed responses to Sierra Club's requests for information.

Sierra Club asserts that it has had only five days to review the responses, whereas all other intervenors have had 14 days to review LG&E/KU's responses prior to the deadline for filing supplemental requests for information, and that five days is not a

sufficient amount of time to review LG&E/KU's responses. Sierra Club argues that an additional three days to file supplemental requests for information will ensure that it has had sufficient time to review the responses, will not disrupt other procedural deadlines and will not unduly delay this proceeding.

The Commission finds that Sierra Club has provided sufficient grounds to support its motion for a three-day extension in which to file supplemental requests for information, and that the procedural schedule in this case should be amended.

IT IS THEREFORE ORDERED that:

1. Supplemental requests for information to LG&E/KU shall be filed no later than March 20, 2014.

2. LG&E/KU shall file responses to supplemental requests for information no later than April 3, 2014.
